# Approval number and validity

The Danish Authority of Social Services and Housing hereby issues the renewal of the GDV approval of

### **SANHA PURAPRESS + PURAFIT**

as a building component that comes into contact with drinking water, cf. section 5(1) of Executive Order No. 1007 of 29 June 2016 on the placement on the market and sale of building components that come into contact with drinking water.

We enclose the GDV certificate for the renewal of the approval with approval No. **03/00077.** 

The renewal of the approval is valid from 24-06-2024 and is valid for a period of five years up to and including 25-06-2029, cf. section 17(1) of the Executive Order.

# Conditions of the GDV approval

The terms and conditions of the GDV approval are stipulated in Executive Order No. 1007 of 29 June 2016 on the placement on the market and sale of building components that come into contact with drinking water, as amended by Executive Order No. 656 of 31 May 2023.

Furthermore, the conditions of approval are:

 The first inspection regarding the approved building component must be completed by the end of 2024

# Basis of approval of the renewal

The renewal of the approval is issued on the basis of the following documentation:

- Solemn declaration that the conditions for renewal of the GDV approval are met, cf. section 17(2) of the Executive Order.
- Solemn declaration on the establishment of a programme of self-checks

### Description and technical data

# Acceptance of the conditions of the renewal of approval

To issue the renewal of the GDV approval, a fee must be paid pursuant to section 21 of Executive Order No. 1007 of 29 June 2016 on the placement on the market and sale of building components that come into contact with drinking water and Executive Order No. 1669 of 12 December 2023 on fees for the construction area by the Danish Authority of Social Services and Housing.

By approving the draft of the GDV approval, you have accepted the conditions of maintaining the GDV approval during the entire approval period, cf. Executive Order No. 1007 of 29 June 2016 on the placement on the market and sale of building components that come into contact with drinking water, as amended by Executive Order No. 656 of 31 May 2023.

## Guidance on meeting the conditions of approval

As the approval holder it is your responsibility to meet the conditions of approval during the entire approval period. Therefore, please be aware of the following main points in order to meet the conditions of approval:

You must establish and maintain a programme of self-checks, including an Incoming & Finished Goods Inspection of the building component approved, to ensure that you

meet the conditions of approval during the entire approval period, cf. section 9(2) and section 10 of the Executive Order.

In connection with the agreement on the annual inspection, cf. sections 11 and 12 of the Executive Order, you must be able to produce information to the supervisory body as stipulated in "Inspection guidelines on building components approved for drinking water", Annex A. You can find the Inspection guidelines on this link: https://sbst.dk/byggeri/byggevarer/building-components-that-come-into-contact-with-drinking-water

Every year you must submit the report on the annual inspection prepared by the supervisory body, to the Danish Authority of Social Services and Housing, cf. section 13 of the Executive Order, in accordance with your inspection agreement with the supervisory body pursuant to sections 11 and 12 of the Executive Order.

The inspections must be carried out once per calendar year for each production site/inspection site. The first inspection during the approval period must be carried out no later than 11 months after the issue of renewal of the approval but no later than the end of 2024 if no inspection report has yet been submitted for this year in connection with the first approval period. During the approval period, five inspections must be carried out evenly distributed over the period. Between two inspections no calendar year must be skipped.

The annual inspection report must be delivered to the Authority no later than two months after the inspection. Later delivery will not be considered in time for maintaining the approval.

If the Authority – in connection with the annual inspection – requires additional documentation pursuant to section 12(4) of the Executive Order, you must give the supervisory body access to conduct this control.

During the entire approval period, the approved building component must continuously meet the relevant product requirements in accordance with the GDV approval. The Authority must be notified on matters that may impact the compliance of the building component with the conditions of the Executive Order, cf. section 16(1).

### Guidance on revocations, termination etc.

The Danish Authority of Social Services and Housing must notify you if the GDV approval is revoked or cancelled or must be revised, cf. section 16(2) and (3) of the Executive Order. This may be the case, if

- supplemental provisions are established or provisions for the area concerned are amended or repealed;
- the building component approved under the scheme is altered and this alteration is
  of significance to matters covered by the approval;
- an inspection finds or it comes to light in another manner that the approved building component no longer meets the conditions that have been stipulated;

- use of the approved building component has unacceptable effects on the building component or its surroundings; or
- the approval holder does not satisfy the conditions established for maintaining the approval, such as performing the required self-checks.

Please be particularly aware to submit the annual inspection report immediately after receipt of the report from the supervisory body. If the Authority does not receive the inspection report in time, the approval may be revoked, and a fee must be paid for the revocation. At the same time, the approval of the building component approved for use with drinking water will be removed from the website of the GDV scheme.

Furthermore, a GDV approval will cease regardless of the expiry date, if rules according to regulations, directives or acts of the European Communities entail an obligation to market in compliance with the provisions contained therein, cf. section 17(3) of the Executive Order.

The Danish Authority of Social Services and Housing will notify you directly of such a revocation of the GDV approval if it becomes relevant in connection with this approval.

### Guidance on renewal

The GDV approval can be reissued for a new period prior to the expiry, if the approval holder provides documentation that the building component continues to meet the conditions for approval, cf. section 17(2) of the Executive Order.

Please be aware that a renewal may imply that the building component must meet new requirements, if the requirements of the Executive Order have been amended during the intervening period.

# The Executive Order on the GDV scheme

The Executive Order on the placement on the market and sale of building components that come into contact with drinking water contains the regulation on the GDV scheme.
